Consistent with ACNP's mission of providing professional and political advocacy for nurse practitioners, the ACNP National Clinical Conference aims to provide curriculum that will develop and enhance the skills of NPs.

The conference abstract submission process has been revised to feature a new technology-based interface, designed for the convenience of the speakers. We anticipate that the simplicity of this online submission system will encourage participation in the conference as well as facilitate the evaluation process. - Providing current clinical knowledge from selected primary care and acute care areas across the life span;
- Exploring evidence-based diagnostic evaluation, management, and prescribing information in client care across the life span;

- Providing a forum for the exchange of ideas and clinical experiences with expert faculty involved in acute care and primary care delivery;
- Providing information on emerging trends in health systems, practice management, and political issues to assist NPs and other health professionals in positioning their practice for the future of health care; and
- Challenging the participants to consider the complexities of an interdisciplinary, highly complex healthcare system as it affects future roles and practice opportunities.

ABSTRACT GUIDELINES

These basic details are required to complete a submission (additional requirements are outlined online):

1. **Presenter** – Must include degrees/certification, institution, mailing address, and contact information, including phone and email. *
2. **Course Objectives** – three objectives for the session (i.e. “At the completion of the presentation, attendees will be able to...”)
3. **Abstract** – 500 words or less
4. **Summary** – 35 words or less, presentation description to be include in the Conference program.
5. **Presenter Biography** – 150 words per presenter; biography should include a summary of each presenter’s educational and practice background that related directly to the qualifications to speak on proposed topic.
6. **Presenter CV/Resume** – This can either be typed into the form directly or attached in a PDF file.

* Abstracts may include up to two co-presenters, including the same presenter information as listed above. The established honoraria will only be provided to the primary presenting author.

All presentations must qualify for continuing education credits (CEUs). This includes appropriate documentation of references. All sessions are ONE HOUR; date and time assignments are designated by the Planning Committee.



SELECTION PROCESS

The ACNP Program Planning Committee will review abstracts for presentation at the Annual Conference and will make selections based on the conference objectives.

Accepted presenters will be notified by April 28th. Upon acceptance, presenters will receive a “letter of agreement” via email outlining the terms of participation at the ACNP National Clinical Conference.
